Minutes for February 26, 2018

The meeting was called to order at 7:00 PM by President Rose McGinnis. A pot luck dinner featuring Sloppy Joe's was held before the meeting. There were 23 people at the dinner and 24 at the meeting. Cheryl Murphy led the Pledge of Allegiance and President McGinnis asked for a moment of silence. Officers present were President Rose McGinnis, Treasurer Tom Minch, Secretary Trent Minch, Executive Committee Member Arnold Benson and Executive committee member Doug Chamberlain.

Introduction of Visitors and Guests – Guest and new member Melody Foster spoke about the feral cat problem plaguing some area residents. Approval of Minutes – Arnie Benson made a motion that the January minutes were to be approved. Paul Raulerson seconded the motion. The motion carried.

Treasurer's Report –Tom Minch reported that our balance this month is \$9440.82. Arnie Benson moved that the report be accepted and Paul Raulerson seconded it. The motion carried. The audit report was also completed by Zeppelin King and found that it was in good order.

Meeting Hall - President McGinnis reported that attendance at the meeting hall in January was 463.

Membership Committee - Tom Minch reported that we now have 66 members for 2018.

Mims Report – Ron Barcher reported that rails to trails paths are open to the public. The opening ceremony was on Saturday February 24th. The trail runs all the way to the Volusia county line. He also spoke about how the library is on schedule. The foundation is already in place and exterior walls are up.

NBP&R – Arnie Benson reported that North Brevard Parks and Recreation will be responsible for maintaining the rails to trail path. He also encouraged SCA members to attend the North Brevard Parks and Recreation meetings, which are held on the 2nd Thursday of every month.

Special Events – Paul Raulerson made a motion that the SCA offer Real Bingo. Zeppelin King seconded the motion. The motion carried on a 11-6 vote. Paul Raulerson made another motion that we spend up to \$50 for a bingo license and \$200 for a bingo blow machine. Arlene Chamberlain seconded the motion. The motion carried.

4th of July –Paul Raulerson made a motion that we have another 4th of July picnic this year, but without the Raffle. Arlene Chamberlain seconded the motion. The motion carried.
