

## Scottsmoor Community Association

### Minutes for April 22, 2019

The meeting was called to order at 7:00 PM by President Cheryl Murphy. A delicious pulled pork dinner was prepared and donated by Doug and Arlene Chamberlain. . There were 31 people at the meal and 38 at the meeting. Cheryl Murphy led the Pledge of Allegiance and afterwards asked for a moment of silence. Officers present were President Cheryl Murphy, Treasurer Tom Minch, Past President Rose McGinnis and Executive board member Doug Chamberlain. Secretary Trent Minch was excused.

**Introduction of Visitors and Guests :** Dwight Siegler, Retha Watson and Gina Stanford.

**Program:** Gina Stanford, the Hummingbird Pantry representative, explained the need and process of distributing food to the needy in North Brevard County. Our Association will be receiving a half truck full of food to be distributed on May 3rd. Volunteers from our Association will be helping, along with the Hummingbird personnel on that date. Because of the heavy pallets and the pallet jack, a temporary floor covering is suggested to protect the floor from being damaged. Future distributions from our site are slated for only the months that have five (5) Fridays in the month.

**Approval of Minutes** – Paul Raulerson made a motion that the March minutes as written be approved, Arnie Benson seconded the motion and it passed.

**Treasurer's Report** –Tom Minch reported that our balance ending for the month was \$ 6,759.70. Paul Raulerson moved that the report be accepted and Rose McGinnis seconded the motion which passed.

**Meeting Hall** - President Murphy reported that 213 people used the meeting hall during the month of March.

**Public Relations** – Arlene Chamberlain reported that cards were sent to Jeff Paronto, Paul Raulerson, and Gina Prudhomme.

**Membership Committee** - Tom Minch reported that we now have 115 members.

**Mims Report** – Ron Barcher thanked everyone who attended the county commission meeting about the rezoning issue. He said the organized speeches resulted in the success of keeping the zoning as is and securing the need for a small area study for Scottsmoor. The county commission agreed to put that matter on their May 2nd agenda, and Ron urged our members to attend and support the study. He also told of the April Mims presentations relating to Food and More and Brevard County's Recycling program.

**NBP&R** – Arnie Benson reported that the improvement work of the softball field at Parrish Park is done. There is also a new gate at the entrance. He thanked those who helped with the landscaping at Scottsmoor Landing. He also reported that a new air conditioner was installed for our building.

**Mail** – None to report.

**Old Business** –Rose McGinnis thanked everyone again for their support of addressing the rezoning issue and attending the county commission meeting regarding it. She then made a motion to have a "Victory Party" at the center which was seconded by Arnie Benson. After much discussion, it was decided not to have the party and the motion failed.

**New Business** – Rose McGinnis nominated Jarred Atkins for the position of Vice President and the motion was seconded by Anita Goforth. Tom Minch, asked that the nominations be closed and Arnie Benson, seconded. Motions passed. Jarred accepted position. Trent Minch's previous request to resign as Secretary was discussed and Alyssa Atkins indicated she would be willing to accept that position. Trent will be submitting his written resignation at the next meeting, and Alyssa will be nominated to replace him. Paul Raulerson made a motion to explore the idea of building a small storage room inside the High Bay area to store more valuable items that belong to SCA. David Laney seconded the motion. After much discussion, motion passed. Paul will report back to membership of his findings, costs, etc. at next meeting.

**Other Considerations** – Rose McGinnis made a motion to spend up to \$ 60.00 for new T shirts, seconded by Paul Raulerson. Motion passed. President Murphy suggested the May meeting be held May 28th on a Tuesday due to Memorial Day on Monday, the 2nd. Membership agreed.

**50/50 Raffle** - The 50/50 raffle was won by Paul Raulerson. The split was \$39.00 to Paul and \$39.00 to the SCA.

**Adjournment** - The motion to adjourn was made by Rose McGinnis at 8:20, seconded and passed by all.
