Membership Committee - Tom Minch reported that we now have 85 members for 2018.

Mims Report – Ron Barcher reported that the library is complete. Books and equipment is being moved in now. Grand opening may be during the end of July.

**NBP&R** – Arnie Benson reported the next North Brevard Parks and rec meeting will be on July 12. Let him know of any issues that need to be reported.

**Special Events** – President Rose McGinnis reported that \$170.11 was made on the monthly meat raffle. She also reported that prizes have been donated for the 4<sup>th</sup> of July picnic (Prizes include tickets to Police museum shooting range, 4 tickets to satellite Cinema, 4 grand slams at Denny's, 3 standard oil changes at Pep Boys, \$40 gift card from River Lanes, and much more to come). Other Considerations – A discussion was held regarding the Amending of the by-laws (to see if there is a need to increase the authority of the board to handle future emergency purchases.) Arnie Benson offered to write a by-laws revision on this subject and will present it at a future meeting.
