

Scottsmoor Community Association Meeting

Minutes for July 22, 2013

The meeting was called to order at 7:00 PM by President Arnold Benson. A potluck dinner was held prior to the meeting featuring grilled hamburgers and hot dogs. There were 24 people at the dinner and 23 at the meeting. Vice President Robert Robbins led the Pledge of Allegiance and President Benson asked for a moment of silence. Officers present were President Arnold Benson, Vice President Robert Robbins and Treasurer Bryan Kyle. Executive Committee Member Doug Chamberlain was excused, and Executive Committee Member Marieanne Syverson was absent. The office of Secretary is open.

Introduction of Visitors and Guests-President Benson introduced Representative Tom Goodson. Representative Goodson introduced his assistant, Amy Gregory. He gave us a brief synopsis of how things work in Tallahassee, talked about the budget and stressed the importance of communicating with your elected officials and parental participation in education. Minutes-The minutes from the previous meeting were read by Treasurer Bryan Kyle. Joe Goforth moved that the minutes be approved and Robert Robbins seconded. The motion carried.

Treasurer's Report-Treasurer Bryan Kyle reported that our current balance is \$10006.01. Joe Goforth moved that the report be accepted and Ed Rost seconded. The motion carried.

Committee Reports

Meeting Hall-President Benson reported that attendance at the meeting hall in June was 372 and briefly discussed the August and September calendars.

Public Relations-President Benson mentioned Joe Goforth's recent stay in the hospital and wished him well in his recovery.

Membership Committee-Bryan Kyle reported that we have 110 paid members, 6 having joined at the picnic.

Mims Report-Ron Barcher reported that there is a move to deregulate the height of cell phone towers on government land. Treasurer Kyle reported that Frisbee's should be open soon.

Special Events-President Benson reviewed the list of prize winners from the picnic and announced that Ed and Cookie Rost won the prize for selling the most raffle tickets. Vice President Robbins thanked the team leaders and picnic sponsors. Treasurer Kyle reported that our profit from the picnic was \$251.23 citing decreased raffle ticket sales and increased expenses.

Old Business-President Benson asked for a volunteer for Secretary. No one volunteered. He reported that he invited a possible new webmaster, Anel Sanchez, to the meeting, but he is out of town.

New Business-President Benson talked about the new shirts that are available for purchase. The shirts are polo shirts that are available in a variety of colors and will have Scottsmoor Community Association embroidered on the front. The cost of each shirt is \$25. He reported that there will be a meeting of the Mims/Scottsmoor Referendum Committee on Tuesday, August 6 at 6PM in the Brevard Room and urged citizens of Scottsmoor to attend. Treasurer Kyle suggested that we have a member appreciation dinner at the Golden Corral in Port Orange. Members would be permitted to bring one non-member guest. Anita Goforth moved that we have the dinner and Glenda Ceballos seconded. The motion carried. A date and time will be decided at the next meeting.

Other Considerations-Lee Bird volunteered to host an ice cream social instead of a pot luck dinner prior to the meeting in August. Glenda Ceballos reported that the new veterans' cemetery has not yet been named, and urged us to contact Commissioner Fisher at D1.commissioner@brevardcounty.gov and Glenn Madderom at Glenn.Madderom@va.gov to suggest that "Scottsmoor" be included in the name. President Benson highlighted two recent articles from the local paper. One detailed budget cuts to the parks services department, and the other talked about launch sites. Juanita Arnold presented a proposal to hold a farmer's market at the meeting hall. She is going to check into licensing and permit requirements.

50/50 Raffle-The raffle was won Representative Tom Goodson. The split was \$29 each. Representative Goodson donated his winnings back to the Association.

Adjournment-The motion to adjourn was made by Trent Minch at 8:42 PM.
